

Operator Accreditation Fees on Application

The table below sets out the provisional and full Operator Accreditation fees.

If you are applying for Operator Accreditation for the first time you will be required to pay the amount set out in the column headed 'Provisional Application Fee (\$)'. For all services other than taxi or limousine, you are required to complete the Operator Accreditation Training Program within three months if you do not possess appropriate training qualifications. Queensland Transport will also undertake a criminal history check.

If you possess the appropriate training qualifications and meet all other Operator Accreditation requirements, you will be issued with full Operator Accreditation. Full Operator Accreditation can be issued from one (1) to five (5) years, in multiples of one year periods. If you would like to obtain Operator Accreditation for more than one year, the Operator Accreditation fee will be the 'Full Application Fee (\$)' multiplied by the number of years the Operator Accreditation is being applied for.

Please note: If you are applying for more than one category of Operator Accreditation, only the highest Operator Accreditation fee applicable is payable. Similarly, if the fee categories are equal, only one fee is payable. If two or more categories of Operator Accreditation are being applied for on the one Operator Accreditation, separate expiry dates cannot be given for each category of Operator Accreditation. In these cases, the Operator Accreditation will be issued for the shortest period of time relating to any category of provisional Operator Accreditation.
